General information about practical exams

Centres must follow the guidance on science practical exams given in the Cambridge Handbook.

Safety

Supervisors must follow national and local regulations relating to safety and first aid.

Only those procedures described in the question paper should be attempted.

Supervisors must inform candidates that materials and apparatus used in the exam should be treated with caution. Suitable eye protection should be used where necessary.

Hazard data sheets relating to substances used in this exam should be available from your chemical supplier.

Before the exam

- The packets containing the question papers must **not** be opened before the exam.
- It is assumed that standard school laboratory facilities, as indicated in the *Guide to Planning Practical Science*, will be available.
- Spare materials and apparatus for the tasks set must be available for candidates, if required.

During the exam

- It must be made clear to candidates at the start of the exam that they may request spare materials and apparatus for the tasks set.
- Where specified, the supervisor must perform the experiments and record the results as instructed.
 This must be done out of sight of the candidates, using the same materials and apparatus as the candidates.
- Any assistance provided to candidates must be recorded in the supervisor's report.
- If any materials or apparatus need to be replaced, for example, in the event of breakage or loss, this must be recorded in the supervisor's report.

After the exam

- The supervisor must complete a report for each practical session held and each laboratory used.
- Each packet of scripts returned to Cambridge International must contain the following items:
 - the scripts of the candidates specified on the bar code label provided
 - the supervisor's results relevant to these candidates
 - the supervisor's reports relevant to these candidates
 - seating plans for each practical session, referring to each candidate by candidate number

Specific information for this practical exam

During the exam, the supervisor or other competent biologist (**not** the invigilator) should obtain the results specified on the supervisor's report by following the relevant steps in the question paper. The results should be recorded in the space provided on the supervisor's report.

Organisation of the exam

- Half the candidates should start on Question 1 and the other candidates should start on Question
 2.
- For Question 2, each candidate must have uninterrupted use of a microscope for at least 55 minutes.

Materials to be supplied by Cambridge International

Slide K1

On receipt of the slides, check that they are labelled **K1** and that no slides are broken. The slides should not be viewed in advance of the exam. The material on the slides is confidential and must not be disclosed to candidates.

The number of slides supplied by Cambridge International will be equal to half the candidate entry.

Return of slides to Cambridge International

Immediately after the exam, the slides must be:

 returned to Cambridge International in the boxes in which they were received, using the self-adhesive label supplied. The slides must **not** be included in the packet of scripts.

Materials and apparatus for Question 1

Each candidate will need:

20% glucose solution in a beaker or container, labelled G , provided at room temperature (see Preparation of materials)	at least 50 cm ³	
20% glucose solution in a beaker or container, labelled U , provided at room temperature (see Preparation of materials) Note: this item is described differently in the question paper. This is intentional. Candidates should not be informed.	at least 10 cm ³	
Distilled water in a beaker or container, labelled W , provided at room temperature	at least 20 cm ³	
[MH] 1 mol dm ⁻³ sulfuric acid solution in a beaker or container, labelled A, provided at room temperature	at least 20 cm ³	
[MH][N] 0.01% potassium manganate(VII) solution in a beaker or container, labelled P, provided at room temperature (see Preparation of materials)	at least 20 cm ³	
10 cm ³ syringes, with the means to wash them out	3	
5 cm ³ syringes, with the means to wash them out	2	
Beakers, capacity 50–100 cm ³	5	
Test-tubes, small, capacity 20–30 cm ³	6	
Test-tube rack, to hold 6 small test-tubes	1	
Container, capacity approximately 200 cm ³ , with tap water labelled For washing	1	
Container, capacity approximately 200 cm ³ , labelled For waste	1	
White card, approximately 10 cm × 10 cm	1	
Glass marker pen, permanent	1	
Paper towels	8	
Stop-clock or timer, showing seconds	1	
Suitable eye protection	1	



Preparation of materials

P must be prepared on the day of the exam.

G and **U** may be prepared the day before the exam and kept in covered containers in a refrigerator.

G, **U** and **P** should be at room temperature before the start of the exam.

• **G** and **U**, 20% glucose solution

This is prepared by sprinkling 20 g of glucose, a little at a time, onto the surface of $80\,\mathrm{cm}^3$ of distilled water stirring continuously as you sprinkle. Make up to $100\,\mathrm{cm}^3$ with distilled water.

[MH][N] • P, 0.01% potassium manganate(VII) solution

This is prepared by putting 1g of potassium manganate(VII) **[O][MH][N]** into 80 cm³ of distilled water. Mix well. Make up to 100 cm³ with distilled water. This makes a 1% solution.

Then put 1 cm³ of the 1% solution into a container and make up to 100 cm³ with distilled water. This makes the 0.01% solution, **P**.



Materials and apparatus for Question 2

Each candidate will need:

Microscope with: an eyepiece lens, ×10 magnification a low-power objective lens, ×10 magnification a high-power objective lens, ×40 magnification 	1 between 2	
Slide K1	1 between 2	

Preparation of materials

Microscope

Any lenses which are **not** ×10 or ×40 should be removed or replaced.

For each candidate:

- the microscope must be set up on low power
- the slide must not be on the stage of the microscope.
